On May 20, 2009, President Obama signed a bill extending the current FDIC deposit insurance coverage through December 31, 2013. The new law means that today's insurance coverage on your deposits up to \$250,000, will remain in place during that time.

Also, Forest Park National Bank is participating in the FDIC's Transaction Account Guarantee Program. Under that program, through June 30, 2010, all non-interest bearing checking accounts are fully guaranteed by FDIC for the entire amount in the account.

The bill also increased the FDIC's Treasury borrowing authority up to \$100 billion, assuring that the FDIC Insurance Fund will be maintained at a safe and sound level.

The new law is good news for all of us while we continue the process of working through the country's difficult economic times. No one knows when the recession will end, but rest assured that we at Forest Park National Bank & Trust Co. will work diligently to protect your deposits and appreciate the trust and confidence you have placed in us.
